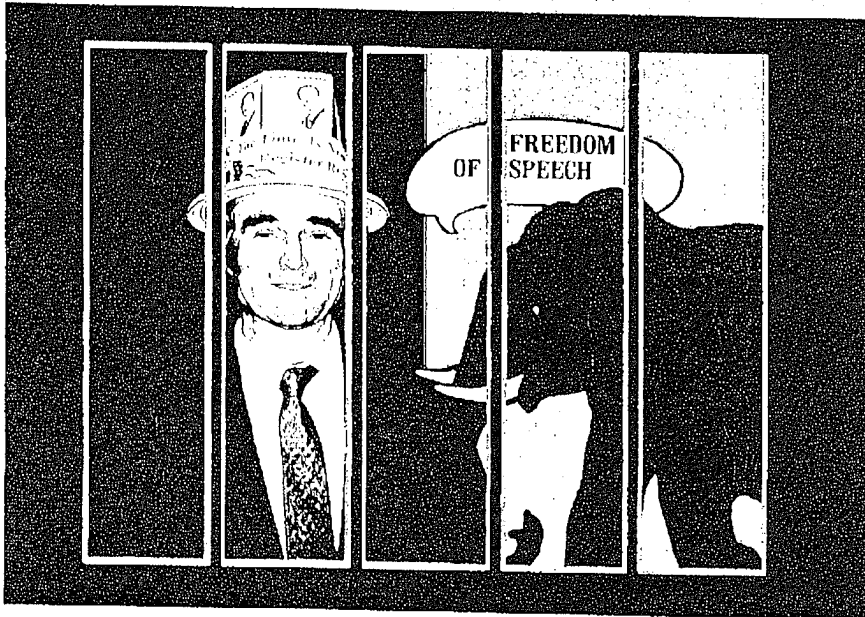

She then joined the faculty at the University of Utah Law School as an Associate Professor and also maintained a law practice in Denver. She was appointed to the Denver County Court in 1977 and to the Denver District Court in 1979, where she served in the criminal and roving civil divisions, was presiding judge of the domestic relations divisions, and was deputy chief judge. In 1983, she was appointed to the Colorado Court of Appeals, served there for almost 20 years, and authored or participated in several thousand opinions covering virtually every field of Colorado law.
